1. This invitation for expression of interest follows the General Procurement Notice (GPN) which appeared in TANePS on 21st September 2022.
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the **Ministry of Foreign Affairs and East African Cooperation** during the financial year 2022 - 2023. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Provision of Consultancy Services For Design and Supervision of Construction Works of Serengeti Delux Villas, Saadani Villas Luxury Homes and Chelston Local Staff Housing Units In Lusaka Zambia..**
 - a. **LOT ONE: Serengeti Deluxe Villas, (8 Semi-Detached Deluxe Villas Duplex with all modern facilities including a swimming pool) on Stand No, 126 & 127 2nd Street Jasmondine- Lusaka;**
 - b. **LOT TWO: Saadani Villas Luxury Homes, (16 Semi-Detached Deluxe Villas Duplex with all modern facilities including swimming pool) on Stand No, 130 & 131 2nd Street Jasmondine; and**
 - c. **LOT THREE: Chelston Local Staff Housing Units (6 Housing Units) on Stand No. 340, Off Poisenttia Avenue, Chelston**
3. The **Ministry of Foreign Affairs and East African Cooperation** now invites eligible firms to indicate their interest in providing the services which include **Provision of Consultancy Services for Design and Supervision of Construction Works**

of Serengeti Delux Villas, Saadani Villas luxury Homes and Chelston Local Staff Housing Units in Lusaka Zambia for the period of 42 calendar days for phase One.

4. Interested *firms* must provide information indicating that they are qualified to perform the services by submitting ***consultant's profile, description of similar assignments, experience in similar nature and conditions, availability of appropriate skills among staff***, etc. Consultants *may* associate to enhance their qualifications.
5. A consultant will be selected in accordance with the procedures set out in the Public Procurement Act No. 7 of 2011 as amended in 2016 and the Public Procurement Regulations, 2013 – Government Notice No. 446 as amended in 2016 (hereinafter called Procurement Regulations).
6. Selection will be conducted through the ***Quality and Cost based*** selection procedures specified in the Public Procurement Regulations.

8. Expressions of Interest (EOI) must be submitted on **www.taneps.go.tz** on or before **3rd March, 2023 at 14.00 hours East African Time.**
